What is the FCHCC?

In 1992, a small group of Hispanic business leaders undertook the task of unifying the Hispanic business community. The Hispanic American Business Association (HABA) was formed and immediately began to advocate for Hispanic business and to promote the region's rich Hispanic culture and heritage. The organization was renamed the First Coast Hispanic Chamber of Commerce (FCHCC) in 2003.

The FCHCC is the strong, unifying voice that promotes Hispanic business throughout Northeast Florida. The organization increases state and national influence for our members through affiliations with both the U.S. Hispanic Chamber of Commerce and the Florida State Hispanic Chamber of Commerce.

The FCHCC has grown to include individual, corporate and non-profit members. In 2005, the FCHCC instituted a Trustee Program for larger corporations and organizations interested in significant and substantial support of Hispanics in business, who are shaping our local, state and national economies.
